# Notice regarding the establishment of a joint venture in Indonesia

We hereby announce that as a result of a board of directors meeting dated April 18, 2014, our subsidiary FUJIO FOOD SYSTEM SINGAPORE PTE., LTD. (herein FFS Singapore) and PT. Prima Garda Andalan (herein PRIMA), have entered into a joint venture for the purpose of expanding our brands in Indonesia, with the "Maido Ookini Shokudo", "Kushiya Monogatari", "Tsurumaru Udon" and our other brands. PRIMA currently owns approximately 60 stores of a major bakery chain in Indonesia called Bread Life, and has the significant know-how and a broad local network that will enable the development of our brands in Indonesia. Moving forward, we will utilize this joint venture with PRIMA to expand the "Maido Ookini Shokudo", "Kushiya Monogatari" and "Tsurumaru Udon" brands as well as our other brands throughout Indonesia.
